# **D-Day 80 Commemoration Arrangements**

# Monthly coffee morning in commemoration of D-Day 80 and raising funds for Royal British Legion

The monthly coffee morning was well attended. The organiser has asked if the room hire could be covered for with the budget for the commemoration events and whether the council could make a donation to the Royal British Legion from the budget set aside for the commemorations.

Receipts for food and refreshment expenditure for the event(s) will be shared with July full council for payment ratification (these are  $< \pm 100$ ).

The budget for D-Day commemorations is £400.

#### Planting a Commemorative Tree

Lovells and the management company support the planting of a tree with plaque in the garden of the fallen. The management company is happy with either a flowering cherry or a flowering pear tree and they clarified the tree would be maintained by the Management Company in future. The cost of a tree is dependent on maturity and species. For a 5' tree prices are around  $\pounds 150-\pounds 200$ , plus stakes, plaque etc



#### Talk with school children

Chris Hewis (Saxilby and District History Group) and Revd Jane Foster-Smith (Priest-in-Charge, Saxilby & Stow Groups of Churches) spoke to school children on Thursday 6 June. The session was so successful they have been invited to return to speak to more children.

#### Social Gathering with Refreshments in Church Hall

The social gathering with refreshments in the church hall was well attended, with themed cakes and a 1940s play list. SIGNS provided food and refreshments, along with volunteers.

#### **Church Service and Bell Ringing**

The church service was well attended and the bells were rung.

#### History Group

The history group provided displays for the church, church hall and village hall as part of the commemorations.

### D-Day80 Flag

The D-Day 80 Flag was flown ( $\pounds$ 17 exc VAT from Royal British Legion)

#### Peace Lamp

The peace lamp was purchased but not delivered in time – having gone missing in the post. The company has been contacted to seek a refund ( $\pounds$ 55).

#### Comms

The events were promoted through council comms and a number of cllrs formally attended the events.

### **RECOMMENDATION(S):**

- I. Planning and development committee note the report.
- 2. Committee agrees the type of tree flowering cherry or flowering pear to be purchased for the garden for the fallen, to be planted in autumn and a tree planting ceremony to be held with local residents invited (budget £200).
- 3. Committee agree to pay for the room hire for the monthly coffee morning in commemoration of D-Day 80 at £20.
- 4. Committee recommend to full council a contribution to the Royal British Legion<sup>2</sup> in commemoration of D-Day 80 from the D-Day 80 budget and agree the amount.
