REPORT

The annual Remembrance Service is to take place at the Memorial on Saturday 9 November from 10:45am.

Permission has been received from Saxilby Recreation Ground to hold the service on the car park as usual. Signage and cones are planned to be put up in the car park the day before to ensure no vehicles are parked within the service area.

The car park barriered off before and during the event. This is for the safety of those taking part in the service in the car park. Sports clubs and Sports Hub have been notified.

Revd Jane Foster-Smith has agreed to lead the service.

Order of service will be printed, including a list of those organisations laying wreaths.

A bugler is confirmed.

Chair, Cllr Hillman lay a wreath on behalf of the parish council.

Local organisations are being invited. Saxilby WI, Saxilby Scout & Guides and Saxilby Fire Service usually lay wreaths and will be invited.

The service is being advertised on social media, on the council's website, in the Foss Focus, and on posters around the community.

Mr Cotton to be invited to read out the names of those who lost their lives.

Chairs will be set out for those who require seating for the service.

The wreaths to be removed after four calendar weeks and organisations contacted to request their collection.ⁱ

Staff will be present to assist.

Refreshments afterwards

Refreshments will be provided in the function room following the service.

Wreath

In-line with the council's sustainability objectives a compostable wreath is to be ordered from the local florist.

The wreath usually contains red poppies as a recognised symbol of remembrance and hope.

A request has been made this year to include white (denoting remembrance for all victims of war, a commitment to peace and a challenge to attempts to glamourise or celebrate war) and purple poppies/flowers (to remember animals in war).

How can councillors support the event?

- Councillors are encouraged to attend this event and wear their cllr badge.
- Donation of a cake.
- Volunteer to sign visitors in
- Volunteer to serve refreshments and cakes
- Volunteer to tidy away after event

ⁱ There is no guidance as to how long wreaths should remain at memorials. In some places they are removed after weeks, in others after months. In most places, the local Legion branch and local authorities agree on a suitable time to take them away. Wreaths laid at the Cenotaph remain there for two weeks after the Ceremony and are then collected.
