Consideration of risk management in relation to the proposal

It is impossible to list every risk faced by a local council. Risk, in the general sense, means the likelihood of an event happening, and the severity of the negative consequences. The insurance industry regards risk as representing loss or damage. Risk always involves uncertainty. REPORT

At November Full Council it was ratified to progress re-siting the mosaic site at the Co-op (FC24/234 10.1.)

Council have agreed that full costings for the project and whether any local trades/college would be willing to be involved, are required from the planning and development committee (FC24/234 10.2.):

"Having been proposed (Cllr Bowden) and seconded (Cllr Bridge), it was RESOLVED, with three abstentions to defer the item 'Delegates the project management and sourcing of funding to the planning and development committee to enable them to progress the project, subject to the planning and development committee defining the budget, obtaining the required funding, and the relevant permissions being in place before commissioning and undertaking the project.' to gain full costings for the project and whether any local trades/college would be willing to be involved (as impacts costs)."

It is proposed that committee members are agreed to progress the project in order to:

- a. Speak to local trades/college to see if they would like to be involved
- b. Identify the required funding/budget/project costs
- c. Bring the plan back to planning and development committee, including plans
- d. Ensure budget/grants cover this prior—bringing back to committee
