### **Request Speed Reduction Measures for Field Avenue**

### REPORT

#### I. Purpose of the Report

To seek committee approval to request that the County Council Highways Authority investigate and recommend appropriate speed reduction measures for Field Avenue, in response to concerns raised.

#### 2. Background

Field Avenue has been the subject of reports from residents and observations by officers regarding excessive vehicle speeds. The road is residential in nature, with frequent pedestrian activity including school children and older residents.

Current signage and traffic calming provisions are minimal, and the road may not sufficiently deter speeding.

#### 3. Proposal

That the council writes to the Highways to:

- Request an initial speed and traffic survey to gather evidence.
- Ask for an assessment of potential speed reduction measures, which could include:
  - Enhanced signage
    - Road markings
    - Speed cushions or humps
    - Vehicle-activated speed signs (VAS)
    - 20 mph zone designation (if appropriate)

#### 4. Considerations

- **Public safety**: Especially important due to the presence of families, children, and older people in the area.
- **Cost**: While Highways may fund surveys and assessment, any physical changes may will require county/parish funding contributions.
- **Consultation**: Engagement with residents and local stakeholders will be key if changes are proposed.

#### 5. RECOMMENDATION(S):

1. That committee notes the report and requests the County Council Highways Department to investigate options for speed reduction on Field Avenue and reports back with findings and recommendations.
