Consideration of risk management in relation to the proposal

It is impossible to list every risk faced by a local council. Risk, in the general sense, means the likelihood of an event happening, and the severity of the negative consequences. The insurance industry regards risk as representing loss or damage. Risk always involves uncertainty. When protecting a local council effectively, it is important to consider if risk is present in the following areas:

The proposals involve minimal risk, primarily related to minor expenditure, councillor availability, and ensuring names are read correctly at the service. Standard mitigation measures, including budget approval, alternate councillor arrangements, and preparation checks, are in place.

REPORT

I. Purchase of wreath

Each year, the Parish Council arranges a local Remembrance Service to honour the fallen. Purchasing a wreath allows the council to formally represent the community during the service. In line with the council's environmental and biodiversity responsibilities, the wreath will be sourced from a local supplier using sustainable materials, such as fresh flowers or biodegradable products, reducing environmental impact.

2. A councillor lead to read names of the fallen

Traditionally, the Chair of the council has read the names of the fallen at the Remembrance Service. The Chair has this year requested that all councillors are given the opportunity to fulfil this role. A nominated councillor will lead part of the service by reading the names of local individuals who lost their lives in WWI, with another member of the community reading the names of the fallen from WW2. This demonstrates the council's commitment to preserving heritage, fostering public participation, and sharing civic responsibilities. The nominated councillor will be given the names in advance in order to prepare, and to ensure accuracy and respectful delivery.

RECOMMENDATION(S):

1. To purchase a wreath for the Remembrance service

2. To agree councillor lead to read the names of the fallen
