- Improve the well-being of residents
- To foster public participation and engagement
- To recognise the climate and biodiversity emergency and it should be considered as the basis of all decision and policy making

Ensuring the event is accessible and welcoming to all will be a central part of the planning and running of events.



Introduction

- 2023 sees the Kings Coronation and 2024 sees D-Day80. The council has some funds set aside towards the Christmas Lights Switch-On event and Kings Coronation (as well as the Waterfront Festival).
- The council's objectives align with holding and supporting community events. In particular the council supports public participation and engagement.
- The council currently has six plus projects in progress including the regeneration of the Waterfront, the refurbishment of Bridge Street Toilets, the MUGA refurbishment, a new speed watch scheme, the recreation ground project 'handover' and reducing the carbon footprint of the community centre which all involve officer time.

Christmas Lights Switch-On Event

- The council has some budget set for the event either to support the arrangements directly or via a local group
- There are a number of potential models to deliver the event from fully officer led, to a council led task and finish group, to an independent community group(s) organising
- An important consideration would be ensuring the management of risk as part of this process
- Facilitating a community group to organise the event immerses and engages residents fully in the process and is in-line with the council's objective of public participation and engagement. This provides a high level of <u>public participation</u> and influence

Proposal

- I. Council support a constituted community group to organise the event
- 2. Council arrange an open meeting in February and invite local organisations and residents to ascertain interest and set-up an event group to lead on arrangements

Kings Coronation

- King Charles III's coronation will take place on Saturday 6 May 2023.
- The council has some funds set aside to offer grants for local community groups to celebrate the event
- The council is centrally placed within the community to facilitate the co-ordinated organisation of celebrations in the community. This is in-line with its objectives of public participation and community engagement

Proposal

- 3. Council assumes a faciliatory role in arrangements to support community organisations co-ordinate their events
- 4. Council arrange a meeting in February and invite local organisations and residents to begin co-ordinating arrangements



5. To use the budget to support arrangements, including those by community organisations

D-Day 80 in 2024

- The 80th anniversary of D-Day is on 6 June 2024.
- Council to consider whether it would like to be involved in marking this anniversary

Proposal

- 6. Council note the date and consider setting aside budget for the 2024/25 budget
- 7. Council arrange a meeting in February and invite local organisations and residents to discuss whether the community would like to mark the occasion and share initial ideas
