



# Saxilby and District MUGA Update

## March 2023

MUGA update to Full Council

Cllr Hewes

The following key activities have taken place.

1. Submission to Football Foundation funding drafted - awaiting change of Land Registry Details to progress
2. WLDC feedback received - planning permission is required for the fencing as they don't have details on file of what was previously agreed
3. Preparatory work carried out.
  - a. Residents overlooking MUGA spoken to about the plans – positive feedback received.
  - b. Fence specification agreed by the Working Group, in-line with Sport England/Football Foundation requirements and potential suppliers reviewed
  - c. Sourcing of three quotes for fence purchase to 19mx37m footprint
  - d. Quotes being sourced for the removal of self-set trees alongside MUGA

The following Preparatory Works are planned to enable progression of the project

4. Removal of old wooden fence 6<sup>th</sup> march – to include tidy up to old fence chain link fence and inspection prior to removal.
5. Removal of old steel post link fence and tidy up to concrete post fence mid-March.

6. Approve the submission of planning application for fencing to original MUGA sizing of 18Mx37M. Original planning application No W85/837/85 provides permission for existing site. Constructed 1986
7. Approve quote for purchase of fencing
8. Approve quotes for removal of remaining self-set trees. Contract selection to be delegated to officers with Working Group approval

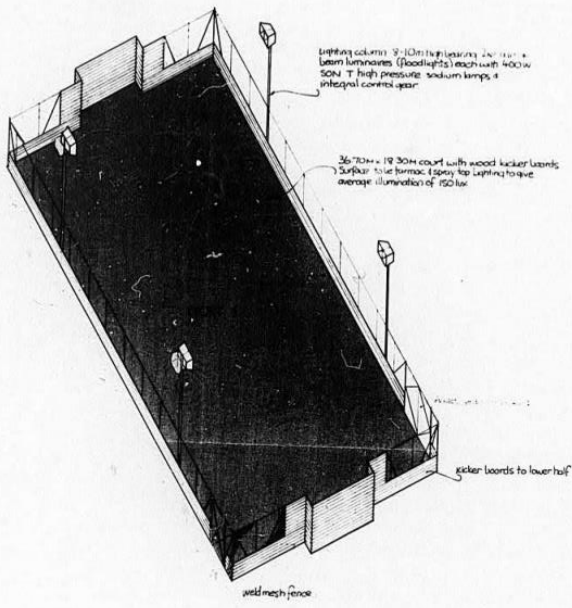
**Part II - Particulars of decision**

hereby give notice in pursuance of the provisions of the Town and Country Planning Act 1971 that **permission has been granted** for the carrying out of the development referred to in Part I hereof in accordance with the application and plans submitted subject to the following conditions:

1. The development must be begun not later than the expiration of five years beginning with the date of this permission.
2. Details of the fencing, flood lighting and flood lighting columns shall be agreed with the district planning authority before any work on their erection and/or installation shall be commenced.
3. The floodlighting hereby permitted shall be terminated every evening no later than 21.00 hours.
